

The Supa Quick PPS Promotion – August 2023

Terms and Conditions

Please read these promotion rules carefully. These promotion rules (“rules”) explain your rights and duties in connection with this promotion. If you take part in this promotion or accept any prize, these rules will apply to you and you agree that the Promoter can assume that you have read and have agreed to be legally bound to these promotion rules.

1. Introduction

1.1 AutoX (Pty) Ltd is running a promotional competition. Purchase a new Willard battery, register the battery online in-store and receive an entry into the competition to win one of two hundred (200) PPS750 portable power units.

2. Definitions

- “Participant” means the person who purchases a new Willard battery and registers the Willard battery online in-store who then receives one entry into the competition.
- Promoter” means Auto X (Pty) Ltd or its agencies used to promote this promotion.

3. How this promotional give-away works?

- On the purchase of a new Willard battery and the in-store registration thereof, participants will receive an entry into the competition. The participant must register their new Willard battery in-store at registermybattery.co.za to be entered into the competition.

4. Duration

- Any entries received after the competition period are invalid.

- On the purchase of a new Willard battery and on the successful online registration in-store of their new battery, each participant will receive an entry to win one of two hundred (200) PPS750 portable power units at the Supa Quick store where they purchased their Willard battery.

- The give-away is not transferable.

6. Draw Dates

The winner will be drawn within 14 days from the competition end date, the end date being the 30th of September 2023. The Promoter reserves the right to extend the competition or change the draw dates. Notice of this will be posted in these rules.

7. Eligibility:

- The promotion is open to all South African residents aged 18 years or over with a valid South African Identity Document and valid driver's license.
- No one who is a director, employee, agent, consultant, spouse, life partner, close family member or business partner of the promoter or the supplier of goods and services in connection with this promotion may enter this promotion.

8. Is there a limit on the number of times you can receive a give-away?

The number of give-aways are limited per participating store, and only one battery warranty registration form can be completed for each new battery purchased. While stocks last.

9. How will the winner be chosen?

The winner will be selected via an electronically generated draw.
